From the Desk of the CEO

Baby Boomers. Nursing Homes. Future.

Over the next decade, 76 million baby boomers will reach retirement age. More than 15,500 skilled nursing facilities (SNFs) provide care to more than 1.35 million people in the United States who need assistance with their Activities of Daily Living (ADLs), including going to the toilet, getting out of bed, getting dressed, feeding themselves, and showering, or who have cognitive difficulties, such as from dementia. Harrington, C. et al. Kaiser Family Foundation. "Nursing Facilities, Staff-

ing, Residents and Facility Deficiencies, 2009 Through 2015". (July 2017). Will adequate numbers of skilled nursing homes be available when the cresting waves of aging baby boomers begin to need services in big numbers over the next two decades? That question has not gotten much attention with any national health policy debate but it needs to.

While it may not be known to the general public, there has been a slow decline in the number of skilled nursing homes across the country over the last decade. For example, "from 2000 to 2009 the total number of nursing homes in the U.S. decreased by 9%. Additionally, from 2007 to 2011 new construction of nursing-home units decreased by 33%," according to CNBC. Many industry experts foresee a continuing downturn in that number of skilled nursing home beds and I do agree. There have been some Iowa nursing homes close in recent years, many throughout the Midwestern states are struggling for a variety of reasons. At Eventide, we continu-

strategically are planning for a successful future. In looking back at Eventide 10-12 years ago, the average patient came in and stayed for three or four years. But today our nursing home population comes in at a much later stage in life when they are older, have a higher acuity and require a lot more care. Or, they are here for a short rehab stay, at any age, to return back to their own home. In either case, their length of stay has dropped dramatically which means more resident turnover leading to more hidden costs such as admission/discharge paperwork requirements, marketing, and

ously monitor the industry, trends and adjust to ensure we

In the early 2000s, Eventide was licensed as 111 skilled nursing beds with an additional 25 residential care beds for a total of 136 beds under one roof. We delicensed those 25 residential beds and built 36 assisted living apartment (Silveridge building) to replace that level of care to better meet tenant needs/desires. Once that was done, we also delicensed 11 skilled nursing home beds and turned some of those residential beds into nursing facility beds to allow for more private resident rooms (about 50% of our nursing facility rooms are private) bringing our number of licensed beds down to 100 in total. Although our nursing facility's average census is in the mid-80 range, it does leave open rooms to allow flexibility

for residents and our ability to admit with availability of more choices plus staff to resident ratios that are desirable.

Meanwhile in today's world, nursing homes face unprecedented levels of 'competition' and it is coming from every direction. With rising healthcare costs, we need to ensure people are provided the right care in the right environment. Some residents who years ago lived in the nursing facility, may be more suitable in a lighter level of care like assisted living. Lighter level of care equals less cost for the consumer. Other

examples of the right environment may include assisted living, adult day care centers, use of home care and a significant push by both state and federal agencies to keep seniors at home through 'home and community-based programs.' Iowa is a little behind on some of these environments but at Eventide, we are monitoring these and other pro-

grams like PACE and the changing reimbursement models such as Bundled Pay-

With medical advances, particularly in orthopedics, some hospital patients who used to go to nursing facilities for rehab are now bypassing those facilities completely. Hospitals discharge some to home-based health care therapy for lower costs which insurance companies will push. On simple cases this works well yet on other cases, the rehab is a longer process for a variety of reasons. Many times, patients face more chronic issues which need to be closely monitored in addition to the orthopedic issue. In house recovery is a full approach model providing other important factors like the right diet, medication administration, enhanced therapy options, and the comfort of knowing someone is there 24 hours a day.

Medicaid (also known as Title 19) in 35 of 50 states pays an average of \$23 below the actual cost of providing care. Facilities with a high number of Medicaid residents will likely see financial losses and I'm sure many can realize the economic implications of this. However, a risk this industry is facing right now as some populations are unable to save for long

In lieu of all this information, there will remain a very strong need for skilled nursing facilities and this is especially true for Crawford County. We may see the number of skilled nursing facilities beds decrease, but there will be other options available to serve residents with the right care in the right environment. As many of you are aware, Eventide leadership is in the middle of designing two new building projects that align with the industry trends and our market to provide the right care in the right environment. With expansion of assisted living yet reducing some skilled nursing facility beds, we will continue to address more options to beyond those we currently offer in the future. With this in mind, we want to provide quality services to those we serve in the most cost-effective manner for both the consumer and provider.

Looking Ahead: Where is Home?

One of the most difficult questions we face as we age is this: "Where will I live?" The natural answer is "home" of course. It's comfortable. It feels safe. I know I can afford it. The truth of the question, though: the answer may not be as simple as it appears.

When most of us think of "home" we think of our houses, our apartments, or simply the space we've called "home" for any substantial period of time. Most of us don't think, or simply don't want to think, about home being in an assisted living or a nursing facility. The reality of it though is that trying to determine where we'll age can be as difficult to predict as the weather. This is because of the extensive array of factors could contribute to the decision, with health and finances being two of the largest influencers of what "home" might look like down the road.

One thing we ARE able to control is the level of preparation we invest in prior to the day the decision has to be made. That preparation could be as simple as having a conversation with loved ones to let them know what your wishes are or maybe even looking

into a long-term care insurance policy "just in case" it might ever be needed. It could be looking at your current house or apartment and deciding if the layout would be able to accommodate a wheel-chair or if you would need to make any other changes to prepare for a decline in mobility or health.

I very recently asked Jared Koch, local financial associate with Thrivent Financial for Lutherans, when the "best age" is to invest in long-term care insurance. His response: "When you're healthy". I used to think the best age to invest in a policy was between the ages of 60 and 65. According to Koch, half of people who wait until even age 57 could be declined because of their health. In fact, he recommends age 50 to be the ideal age to invest in a policy. Moral of the story: it's never too early to start asking questions and educate yourself. It's just another way to be prepared.

Something that really seems to be trending is the big push toward home and community based services. While these programs truly are wonderful and may seem like the obvious solution to allowing us to stay in our homes, are they really the most cost effective?

A recent article published in CNBC really

shed some light on this very topic. I'll summarize it for you. As we age, we usually see a general weakening of the bones and muscles along with a natural decline in mobility and energy. When combined, these could make everyday tasks difficult or even dangerous. Some retirees may think a homemaker is a great solution, not realizing the average monthly cost of a homemaker is \$3,994 for 44 hours of care per week (according to AARP research).

Another thing to consider is our age progression may require changes to our home's design or layout. Things such as grab bars, handrails, replacement flooring, lighting improvements, stair height reductions, widening hallways, ramp installations, lowering cabinets, bathtub/shower replacements or modifications, etc. could range from \$10,000 - \$100,000 in added costs.

Other things to think about: If you fall, how long would you have to wait before someone found you? If you no longer drive, how will you receive the social stimulation you need to prevent feelings of isolation, depression or loneliness? If meal preparation becomes difficult, how will your nutritional needs be met? Who will mow

your lawn next sum-

mer? What happens if your furnace quits working this winter? Of course, you can hire someone to take care of things such as these, but they all come with a price tag and can be stressful situations.

The point of this article isn't to promote or discourage any one option over another. It's simply to get the wheels turning and maybe cause us to ask ourselves, "Where will I live?" Looking into options early and thorough enough to feel prepared, can really be imperative should a transition ever be needed. Before making any choices or immediate preferences or assumptions, consider the financial, social and health implications for each scenario. While assisted living or a nursing facility may not seem like an obvious first choice, they're definitely worth weighing out your pros and cons. Use the resources available in your community to help you to become as prepared as you can be for the day you may need to make a decision regarding where you will age. Lynch, M. (2018,

5 Star Rating Change

for Medicare and Medicaid Services Five-Star Quality Rating System. Launched in 2008, the national rating system was designed to make it easier for consumers to compare nursing homes and other entities that participate in Medicare or Medicaid. It uses information collected from health care surveys, quality measures and staffing patterns to rate a nursing home from one to five stars, much like a restaurant review system. Nursing homes with 5 stars are considered to have much above average quality and nursing homes with 1 star are considered to have quality much below average.

No rating system can address all of the important considerations that go into a decision about which nursing home may be best for a particular person. There are some pros and cons to this rating system as this is not always a true reflection of an individual facility's quality. Here is an example that occurred for Eventide. Recently the

Many of you may be aware of the Center way a nursing facility submits staffing data has changed and those changes have been included in facilities' 5 STAR Quality Rating System effective April 2018. With this change, a technical issue occurred which did not include any non-exempt LPNs that were Eventide employees, therefore making our staffing levels appear much, much lower than they actually were. This reflection shows in our staffing measure. This technical issue has been resolved but will not be reflected on the new reporting system for an additional 6 months. This staffing technical issue has dropped Eventide from an overall rating of 5 stars (the best) to 4 stars.

> Rest assured, Eventide will continue to give the 5 star care that we earned through our quality measures and strives for the perfect 5 STAR overall rating. 24 Servings • 9x12 pan

1 c margarine, melted 1 c graham cracker crumbs 34 cup white sugar

2 lbs. cheesecake mix 3 c sliced bananas

1/8 brown sugar 1/2 # whipped topping, prepared ½ c caramel topping

Melt margarine and combine with graham cracker crumbs and sugar. Press into bottom of pan. Pour milk in mixing bowl and add cheesecake mix. Blend with wire whisk attachment on low speed for 30 seconds. Scrape bowl well. Whip on medium for 2 minutes. Do not overwhip. Sprinkle bananas with brown sugar. Fold bananas into cheesecake mixture gently to combine. Pour filling into graham cracker crust. Top with whipped topping. Drizzle with caramel topping. Chill at least 1 hour and preferably overnight.

Resident Rights

Information and Communication: The resident has the right to be informed of his or her rights and of all rules and regulations governing resident conduct and responsibilities during his or her stay in the facility.

A. The resident has the right to access personal and medical records pertaining to him or herself.

- a. The facility must provide the resident with access to personal and medical records pertaining to him or herself, upon an oral or written request, in the form and format requested by the individual, if it is readily producible in such form and format (including an electronic for or format when such records are maintained electronically); or, in not, in a readable hard copy form or such other form and format as agreed to by the facility and the individual, within 24 hours (excluding weekends and holidays); and
- b. the facility must allow the resident to obtain a copy of the records or any portions there of (including in an electronic form or format when such records are maintained electronically) upon request and 2 working days advance notice to the facility. The facility may impose a reasonable, cost-based fee on the provision of copies, if the fee includes only the cost of:
 - i. labor for copying the records requested whether in paper or electronic form;
 - ii. supplies for creating the paper copy or electronic media if the individual request that the electronic copy be provided on portable media; and
 - iii. postage, when the individual has request the copy be mailed
