The Power of Words

tongue. We can use this tool for remarkable things. We can lift others up when they are feeling down, provide comfort in a time of sorrow, express love to those we care about, educate others and spread powerful messages, etc. The possibilities are endless. There is so much good that can come from our words.

Yet at the same time, our words can also carry a great burden and have an incomprehensible impact if they are not used in the way Jesus taught us. Many of us have experienced the heaviness of words at some point in our lives. Whether it be a schoolmate, a family member, or even a complete stranger, if someone has said something to you or about you or a loved one that caused you pain, it is difficult to forget. In some cases, it can even have a significant impact on your life. Negative words can cause self-esteem issues, instill fear, and unfortunately can resonate and spread like wildfire.

In Psalm 39:1 it says, "I will guard my ways, Lest I sin with my tongue; I will restrain my mouth with a muzzle, While the wicked are before me." Jesus' teachings remind us that we are to love our neighbor as ourselves. Even more importantly He said to LOVE our enemies and pray for them. So why are we so liberal with our words? Why do we use our tongue in hurtful ways? Why are we so judgmental of what is foreign to us? I, personally, think we tend to fear what we do not understand. If our minds are in a state of fear or misunderstanding, it is difficult to think clearly. We often act on emotion rather than rationale. While we may not understand or agree with those around us, there are few simple questions we can ask ourselves before using our power of tongue:

If the answer to any of those questions is 'no', then Jesus would likely not want us to say it... whether it is to someone or about someone.

I challenge us during these warm summer months to focus on the power of our words and work to use them positively. Be mindful of the impact they can have on others. Let us ask ourselves these 5 questions on a routine basis so they become part of our conversational routines and it just may result in the power of our words being incredibly positive!



What to know about Medicare when you Travel Abroad

Medicare usually doesn't cover health care while you're traveling outside the U.S. There are some exceptions, including some cases where Medicare Part B (Medical Insurance) may pay for services that you get on board a ship within the territorial waters adjoining the land areas of the U.S.

Medicare may pay for inpatient hospital, doctor, ambulance services, or dialysis you get in a foreign country in these rare cases:

• You're in the U.S. when a medical emergency occurs, and the foreign hospital is closer than the nearest U.S. hospital that can treat your medical condition.

• You're traveling through Canada without unreasonable delay by the most direct route between Alaska and another state when a medical emergency occurs, and the Canadian hospital is closer than the nearest U.S. hospital that can treat the emergency.

• You live in the U.S. and the foreign hospital is closer to your home than the nearest U.S. hospital that can treat your medical

condition, regardless of whether an emergency exists.

In some cases, Medicare may cover medically necessary health care services you get on board a ship within the territorial waters adjoining the land areas of the U.S. Medicare won't pay for health care services you get when a ship is more than 6 hours away from a U.S. port. Medicare drug plans don't cover prescription drugs you buy outside the U.S.

The 50 states, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, Guam, the Northern Mariana Islands, and American Samoa are considered part of the U.S.

Because Medicare has limited travel medical coverage outside the U.S., you may choose to buy a travel insurance policy to get more coverage. An insurance agent or travel agent can give you more information about the cost of travel medical insurance. Travel insurance doesn't necessarily include health insurance, so it's important to read the conditions or restrictions carefully.

Resident Rights

- **Information and communication (cont.)**: The resident has the right to be informed of his or her rights and of all rules and regulations governing resident conduct and responsibilities during his or her stay in the facility.
- H. The resident has the right to have reasonable access to the use of a telephone, including TTY and TDD services, and a place in the facility where calls can be made without being overheard. This includes the right to retain and use a cellular phone at the resident's own expense.
- I. The resident has the right to send and receive mail, and to receive letters, packages and other materials delivered to the facility for the resident through a means other than a postal service, including the right to:

- ii. Access to stationary, postage, and writing implements at the resident's own expense.
- J. The resident has the right to have reasonable access to and privacy of their use of electronic communication such as email and video communications and for internet research.
 - i. If the access is available to the facility
 - ii. At the resident's expense, if any additional expense is incurred by the facility to provide such access to the resident.
 - iii. Such use must comply with state and federal law.
