From the Desk of the CEO

As I write this article, there are many thoughts circulating in my mind with many uncertainties at this time locally and around the world. What I am certain of, however, is the team on the Eventide Campus is doing everything possible to protect this community from what may come our way. With daily protocol changes, the team has united together for one common purpose. It has not been an easy task, but I want to give reassurance to those reading the Eventide Events, we have dedicated our resources to be proactive during this pandemic. We understand things may get worse before they get better but we are keeping our spirits up and thankful for what we do have. As the situations surrounding this pandemic continue to change and evolve, what will not change is our commitment to do everything we can to help ensure the health and safety of everyone in our community.

As we monitor the industry and environment, I want to give an update on the replacement of the nursing facility building project. We continue to work with USDA for permanent financing once the building is built and was informed funding for our project has been awarded. We also have been working on obtaining a construction loan and have received a commitment letter with First National Bank of Omaha. We are going through and completing our due dili-

gence items with USDA and First National Bank. In March, the Eventide Board of Directors selected Lueder Construction based out of Omaha, NE for the preconstruction phase. The team of Lueder Construction has exceptional experience in senior living and has worked with some of the highest reputable providers in the Midwest. In addition, Lueder Construction has a proven track record dating back to 1884 as a successful contracting company. Along with our selected architects Community Living Solutions, Eventide Leadership and Lueder Construction will be finalizing the remaining 10% of our plans and will soon seek to bid the project in concurrence with USDA. Stay tuned for future updates.

At this time, we shall not give in to the fear. A proper strategy — diversification, a strong portfolio, specific goals and risk tolerance — should not be deserted. The market will have a variety of highs and lows, but history shows recovery will come.

In closing, I want to extend a sincere thank you to the families, employees, residents, and tenants for your support during these unprecedented times. Please continue to practice social distancing and encourage others to do the same. We all have a part to play so please offer positive words of inspiration to each other. Please pray for the guidance and resources needed to take this pandemic head on.

Coping with Grief and Loss

Grief is a natural response to loss. It is the emotional suffering you feel when something or someone you love is taken away. Often, the pain of loss can feel overwhelming. You may experience all kinds of difficult and unexpected emotions, from shock or anger to disbelief, guilt, and profound sadness. The pain of grief can also disrupt your physical health, making it difficult to sleep, eat, or even think straight. These are normal reactions to loss—and the more significant the loss, the more intense your grief will be. Coping with the loss of someone or something you love is one of life's biggest challenges.

Even subtle losses in life can trigger a sense of grief. For example, you might grieve after moving away from home, graduating from college, or changing jobs. Whatever your loss, it is personal to you, so do not feel ashamed about how you feel, or believe that it is somehow only appropriate to grieve for certain things. If the person, animal, relationship, or situation was significant to you, it is normal to grieve the loss you are experiencing.

Grieving is a highly individual experience; there is no right or wrong way to grieve. How

you grieve depends on many factors, including your personality and coping style, your life experience, your faith, and how significant the loss was to you. Inevitably, the grieving process takes time. Healing happens gradually; it cannot be forced or hurried—and there is no 'normal' timetable for grieving. Some people start to feel better in weeks or months. For others, the grieving process is measured in years. Whatever your grief experience, it is important to be patient with yourself and allow the process to naturally unfold.

The pain of grief can often cause you to want to withdraw from others and retreat into your shell. But having the face-to-face support of other people is vital to healing from loss. Even if you are not comfortable talking about your feelings under normal circumstances, it is important to express them when you are grieving. While sharing your loss can make the burden of grief easier to carry, that does not mean that every time you interact with friends and family, you need to talk about your loss. Comfort can also come from just being around others who care about you. The key is not to isolate yourself.

Peanut Butter Cup Lush



- Ingredients:**
- Serves 9
 - 1 pkg Oreo Cookies, crushed
 - ½ cup Butter, melted
 - 1 (3.4 oz) Chocolate Pudding Mix
 - 1 ¾ cup Milk
 - ¼ cup Creamy Peanut Butter
 - 1 (16 oz) Whipped Topping
 - 1 cup Chopped Reese's Peanut Butter Cups
 - ¼ cup Chocolate Syrup

Directions:
Liberally grease an 8x8" square baking dish with cooking spray. In a large bowl, toss together the coarse Oreo crumbs and the melted butter until moistened and combined. Press evenly into the bottom of the pan, compacting slightly with a measuring cup or your hands. Set aside. In a large bowl, add in the pudding mix, milk and peanut butter. Whisk for 2 minutes or until thickened. Fold in HALF of the whipped topping until creamy and combined. Spread into the prepared pan in an even layer. Top with the remaining whipped topping. Sprinkle on the peanut butter cups. Refrigerate uncovered for at least 6 hours, preferably overnight, before cutting into squares to serve. Drizzle chocolate before serving.
