A Year in the Life ...

On March 10, 2020, we stood in the Main Dining Room after Bingo and explained to the residents, volunteers, and families that we needed to close our doors due to the coronavirus. We explained this was to help flatten the curve and we would reassess 2 weeks later. Little did any of us know, we were in for a world changing pandemic.

One year later, we can be proud of the strength of our staff to endure all the changes, the losses, and the uphill battles. We can be proud of the resiliency of our residents enduring all the changes from isolating in rooms, staying in their households, no in person visitors and learning to visit with Zoom or Facetime on iPads to the changes of reopening for activities and dining. All these changes were made to protect our Residents and each other.

A little timeline to remember what this past year had in store for all of us.

MARCH

Eventide closed the doors to visitors. We learned what the words social distance meant; no more than 10 in a group; designate someone to go to grocery store. We started screening employees when they arrived at work. The Isolation/Quarantine area is set up on the back side of Legacy Center for any positive cases and new admissions. Mail and all packages for residents is held for 24 hours before it is delivered.

APRIL

The CDC suggests cloth face masks are to be worn out in public areas. In the nursing facility, PPE such as surgical face masks and eye protection must be worn for all patient cares. As of 4/6/20 there are 4 positive cases in Crawford county. Residents start "in room dining". Governor Reynolds urges people to stay home and stay safe. Instruction to staff to stay 6 feet apart in break room and to alternate break times.

<u>MAY</u>

Additional symptoms of COVID are released by the CDC. Since the start of the pandemic, there have been 30 COVID19 tests completed on campus with 3 positive tests in employees and the remaining are negative. The (NP) nasal swab and/or serology testing for antibodies will be available on campus and results will be known in 72 hours – employees are highly encouraged to be tested. Crawford County currently has 149 cases and there is talk of reopening businesses in the community.

Crawford Co has 336 positive cases (+177 cases since last week). State Surveyors were here for our first infection control survey and there were no concerns/citations.

<u>**IUNE**</u> – We truly had a good summer considering we are in a pandemic.

CDC and CMS releases phased reopening guidelines for nursing facilities. We encourage staff, visitors, and families to reach out to Governor's office to encourage conservative use of PPE so we can move to Phase 2 of reopening. There are now 654 positive cases in Crawford County.

JULY

New guidance is released for outdoor visits so Eventide and Silveridge can start scheduling visits. There are now 672 positive cases in Crawford County. Eventide moves to Phase 2 of reopening guidelines. Hallelujah! The beautician is allowed back into the nursing facility. There are 21 nursing facilities in Iowa in outbreak status – Eventide is not one of them.

AUGUST

There are now 721 positive cases in Crawford County. New guidance released says residents can go out for medical appointments and not quarantine for 14 days. Nursing facility has one COVID positive staff, the first positive since May. Nursing facility remains in Phase 2 and indoor compassionate care visits need to be scheduled.

SEPTEMBER

There are now 861 positive cases in Crawford county. We will begin testing all nursing facility employees routinely. Guidance is updated to follow county positivity rate to determine if the residents can have outdoor visits or indoor visits. Activities and meals may happen in dining areas with social distancing of residents.

OCTOBER

There are now 1152 positive cases in Crawford County. There are now nine residents that have tested positive in nursing facility. We expanded quarantine/isolation area on Legacy Center from smoke door to smoke door to accommodate any positive cases and any new admissions. Residents are eating in their rooms and activities are going from room to roomand the second infection control survey by the State of Iowa at nursing facility results in no con-

cerns or citations. We celebrated Halloween with staff going room to room in Halloween costumes and handing out goodies to the residents.

NOVEMBER

There are now 1469 positive cases in Crawford county. Routine COVID testing of employees at nursing facility is twice a week. One household becomes a quarantine area – we are limiting the staff that enter that household. We have 7 positive residents currently. Governor Reynolds says the COVID 19 SURGE is at a dangerous level in Iowa. The third infection control results in no concerns or citations.

DECEMBER

There are now 1834 positive cases in Crawford county. All households except Traditional Ridge have positive cases in residents. We celebrated Christmas with resident presents and of course Santa.

Eventide received news that the vaccine will be available in January.

<u>JANUARY</u>

There are now 2161 positive cases in Crawford county. During the first offering of the COVID vaccine, 48 residents and 47 of staff/volunteer/contract staff received the vaccine. All residents tested negative, and all households can go out for meals!

FEBRURARY

There are now 2368 positive cases in Crawford county. More individuals on campus receive both doses of vaccine. Activities and Church on Sundays has resumed – of course, with social distancing and masks worn by all.

MARCH

There are now 2743 positive cases in Crawford county. Eventide can start indoor visits per CMS guidance when Crawford County is in the yellow or green zone or under 10% positivity rate and when out of outbreak status. Friends and families can now visit in person with residents but need to follow the Core Principles of Infection Prevention with focus on use of hand sanitizer by visitors and residents; and visitors need to be able to tolerate wearing a well-fitting face mask. Visitors need to be screened and we need to limit the number of visitors in our building at one time. As more people get the vaccine, we look for more guidance from CMS and DIA to allow our residents and staff more freedom.

Team members and residents shared memories and had a moment of silence for those we lost in the past year. Moving forward, we anticipate a year filled with visitors, entertainment and much

Long Term Care Medicaid Programs for the Elderly

Medicaid is a nationwide program that offers health insurance to low-income residents of the United States. While the federal government sets the parameters of this program, each state is permitted to operate its Medicaid program as they see fit within those given parameters. In Iowa, Medicaid is a managed care program that is administered by the Iowa Department of Human Services' division of Iowa Medicaid Enterprise (IME).

The Iowa Medicaid program, also known as Title 19, will cover the cost of nursing facility care, in addition to limited home and community-based services. There are several different Medicaid long-term care programs for which Iowa seniors may be eligible. These programs have slightly different financial and medical eligibility requirements, as well as varying benefits.

Facility Medicaid

The Facility Medicaid program provides assistance to those who reside in a nursing facility. This is an entitlement program, meaning that anyone who meets the eligibility requirements is offered assistance. When receiving facility assistance, all of the recipient's income, with the exception of a monthly personal needs allowance of \$50 and a spousal income allowance (if applicable), will go towards the cost of the facility care and Medicaid will provide the remaining ex-

Medicaid Waivers

Medicaid Waivers are intended to provide long-term care for those who are elderly and / or disabled. They are meant to provide these individuals support and services to assist them in aging in their homes and communities, rather than being placed in a nursing facility.

Waivers limit the number of program participants. Once the enrollment cap has been reached, there will be a waitlist for services.

HCBS Elderly Waiver – The Home and Community Based Services Medicaid Waiver is intended to provide in-home services to those seniors who require care equivalent to that which is provided in a nursing facility. Program participants have the option of directing their own care and hiring the care attendant of their choosing, including their own adult children. Other benefits may include attendant care, adult day care, home health aide, nursing care, chore services, home and vehicle modifications and personal emergency response systems.

Health and Disability Waiver – This waiver is intended for physically disabled individuals under the age of 65. Those enrolled in this program are allowed to choose their own attendant care worker, regardless of whether they live at home or in an assisted living facility or adult foster care home. Supportive benefits include homemaker services, meal delivery, respite care, personal emergency response systems and nutritional counseling.

Traditional Medicaid / Aged Blind and Disabled

This is another entitlement program intended for Aged Blind and Disabled. If one meets the eligibility requirements, services can be received. Assistance is provided at home or in an adult day care.

Eligibility Requirements

- Residency and Citizenship the applicant must be a U.S. Citizen (or have proper immigration status) and must be a resident of Iowa.
- Age/Disability the applicant must be age 65 or older, blind, or disabled. The applicant must also meet certain medical requirements consistent with the level of care requested.
- Income Limitations For Medicaid eligibility purposes, all income that a Medicaid applicant receives is counted, including wages, Social Security benefits, pensions, veteran's benefits, annuities, IRAs, etc. The total income must be less than \$2,382 per month to qualify.
- Asset Limitations The asset limitations vary based on marital status and if one or both spouses are applying for

assistance. Medicaid divides assets into two categories: Countable and Exempt. Some examples of Countable Assets include: Cash, Checking/Savings/Credit Union Accounts, stocks, bonds, investments, Life Insurance policies, Annuities, and real estate in which one does not reside. Exempt assets are specifically designated under the Medicaid guidelines and will not result in a denial of benefits. Exempt assets include personal belongings, such as clothing, household furnishings, an automobile, an irrevocable funeral contract, burial plots, and one's primary home if the Medicaid applicant lives in the home or expresses "intent" to return to it. If an asset is not listed as exempt, then it must be liquidated and applied toward the costs of long-term care before the applicant can qualify for Medicaid benefits.

When considering assets, it is important to know that Iowa has a Medicaid Look-Back Period of 60 months dated back from the date of the Medicaid Application. Medicaid will verify that no assets have been gifted, transferred, or sold for less than fair market value during the previous 60-month period. If it is found that assets have been disposed of for less than fair market value, a penalty period will be established, and the applicant will be ineligible for Medicaid for the duration of the penalty period.

Resident Rights

Planning and Implementing Care (cont.):

The resident has the right to be informed of, and participate in, his or her treatment, including:

- The facility shall inform the resident of the right to participate in his or her treatment and shall support the resident in this right. The plan process must:
 - Facilitate the inclusion of the resident and/or resident representative
 - Include an assessment of the resident's strength and ii. needs
 - Incorporate the resident's personal and cultural preferences in developing goals of care
- The right to be informed in advance, of the care to be furnished and the type of caregiver or professional that will furnish care.

Eventide Board of Directors
