From the Desk of the CEO

"How are you doing?" It is the common question we ask others we have not seen in a while. The common reply is, "Good, how are you?" The conversation usually does not take a deep dive into what is really going on. So, in my view, here is the answer to how we are doing on the Eventide Campus.

For starters, the Eventide Campus is truly filled with great team members. They are the biggest asset to our organization and always will be. This team is working hard to meet the needs of those we serve, and I am proud of their dedication, hard work, heart, and positive attitudes. Retention and recruitment of quality team members is one of our pressing challenges right now. And we are not alone.

A recent press release by the American Healthcare Association shows a survey they conducted revealed 99% of nursing homes and 96% of assisted living facilities in the US are facing a staffing shortage. A LeadingAge article released today recounts their survey results where several respondents need to hire at least 50% more staff to become fully staffed. This survey also reports 25% had challenges causing them to shut down households or buildings. I have spoken to several healthcare professionals around the area, around the State of Iowa, and around the Nation with severe workforce shortages. Google the words 'healthcare workforce shortage' and you will see hundreds of recent posts about how serious this is. Frankly, and how serious it is yet to be.

I know many businesses are experiencing workforce challenges. We have experienced the effects on those who serve us. From the local restaurant with reduced hours, to the longer waits of customer service with other businesses. Our construction project on Campus has faced delay while awaiting a variety of products to arrive. Many hospitals do not have the staffing or resources to utilize all their beds. The Centers for Medicare and Medicaid Services (CMS) website tracks many COVID related statistics including hospital bed availability. However, they do not track staffed beds available which is a completely different number than what they are showing on the website.

My focus here is to explain how this workforce challenge affects those Eventide serves. For one, our nursing facility may not be able to take a new admission if staffing levels remain low. We want to keep our staff to resident ratios in line with providing quality care. As of today, we have a waiting list at the nursing facility. This list changes daily, but our nursing facility

has turned down many more referrals this year than we have admitted due to staffing limitations. If you or a loved one are anticipating a move to our nursing facility, or any other facility, you may want to plan ahead. I encourage you to call the facility and discuss the situation with the admissions team.

The other admission factor in nursing facilities is if a resident is not fully vaccinated, the resident will basically need 1-1 care for the first 14 days for the quarantine period. Until this guidance changes, many nursing facilities may not be able to provide 1-1 care, and therefore may decline the referral. I mention this not as a mandate for admission, but simply to create awareness that admitting a new unvaccinated resident can be difficult until the guidance changes (or staffing levels increase).

As of today, Silveridge Assisted Living, Heritage Heights and Realife are currently accepting new tenants. All these buildings are part of the Eventide Campus. Those living on Campus may be placed on a priority list for admissions to the nursing facility (Eventide).

It seems having workforce challenges is a topic leadership does not want to publicly speak about. I feel it is important for others to understand our challenges so we can meet the expectations of those we serve. Some will blame the pandemic; it certainly did not make things any easier. The pandemic with all its new regulations is something that has not gone away in our industry, but rather keeps growing month by month. Some will blame the vaccine mandates as individuals choose another career. Some will blame government for policies implemented or even for lack of implementation in other areas. Some will blame leadership within that company for not offering better resources to their employees. All the above need to continue to make adjustments to overcome with workforce challenges.

Our team is ready to serve and will do so in the best way we can. We need investment strategies from policymakers with 'The Care For Our Seniors Act' to provide necessary and stable financial support. We will continue to advocate for changes with our policymakers. Our team needs verbal support from our community and positive words of encouragement. Our leadership continues to adjust benefits offered to employees as we strive to retain and recruit great team members. Our leadership is committed to the future and that shows with the reinvestment of funds back towards the campus...to our employees, facilities, and services.

Medicare Open Enrollment for 2022

Medicare open enrollment - also known as Medicare's annual election period - runs from October 15 through December 7 each year. During this annual window, Medicare plan enrollees can reevaluate their coverage - whether it's Original Medicare with supplemental drug coverage, or Medicare Advantage - and make changes or purchase new policies if they want to do so.

During the Medicare open enrollment period, you can:

- Switch from Original Medicare to Medicare Advantage (as long as you're enrolled in both Medicare Part A and Part B, and you live in the Medicare Advantage plan's service area).
- Switch from Medicare Advantage to Original Medicare (plus a Medicare Part D plan, and possibly a Medigap plan).
- Switch from one Medicare Advantage plan to another.
- Switch from one Medicare Part D prescription drug plan to another.

- Enroll in a Medicare Part D plan if you didn't enroll when you were first eligible for Medicare. If you haven't maintained other creditable coverage, a late-enrollment penalty may apply.

Prior to 2021, patients with end-stage renal disease were unable to enroll in Medicare Advantage plans unless there was a Medicare Special Needs plan available in their area for ESRD patients. But that changed as of 2021, under the terms of the 21st Century Cures Act. People with ESRD gained the option to enroll in Medicare Advantage as of 2021. This can be particularly advantageous for beneficiaries with ESRD who are under age 65 and living in states that don't guarantee access to Medigap plans for people under the age of 65.

For those in the nursing home utilizing therapy, our experience shows advantage plans may not provide as good of coverage as original Medicare. For assistance, please call 712.265.2509 to talk to the local SHIIP (Seniors' Health Insurance Information Program) Counselor.

Caramel Apple Pie Pizza



Dough for a single-crust pie

APPLE FILLING INGREDIENTS

- 2 1/2 cups apples peeled and cut into 1/2 inch slices
- 2 tablespoons flour
- 2 tablespoons brown sugar
- 1/2 teaspoon cinnamon
- 1/4 teaspoon nutmeg

STREUSEL INGREDIENTS

- 1/2 cup flour
- 1/2 cup cold butter
- 1/3 cup brown sugar
- 1/2 cup rolled oats

DIRECTIONS

1. Preheat oven to 350°. On a lightly floured surface, roll dough to fit a 12-inch pizza pan; fold under or flute edge.
2. Peel and slice the apples. Toss them with the flour, brown sugar, cinnamon and nutmeg.
3. Arrange apples in a single layer to completely cover the crust.
4. To make the streusel, mix together the flour and brown sugar. Cut in the cold butter until it makes pea-sized crumbs. Gently stir in the oats. Sprinkle over the apples.
5. Bake at 350° for 35-40 minutes or until the apples are tender and the crust is browned. Let cool slightly. Serve warm with caramel and vanilla ice cream.

During that time Marley was a part of the largest seizure of narcotics in Iowa yet to date, having apprehended 10,500lbs of marijuana in a single traffic stop. The marijuana was said to have street value of 'millions of dollars' even back then, and was packaged in 50lb bales. It was something for the record books.

Resident Rights

Respect and dignity:

The resident has a right to be treated with respect and dignity, including:

- n. The right to be free from any physical or chemical restraints imposed for purposes of discipline or convenience, and not required to treat the resident's medical symptoms.
- o. The right to retain and use personal possessions, including furnishings, and clothing, as space permits, unless to do so would infringe upon the rights or health and safety of other residents.
- p. The right to reside and receive services in the facility with reasonable accommodation of resident needs and preferences, except when to do so would endanger the health or safety of the resident or other residents.
- q. The right to share a room with his or her spouse when married residents live in the same facility and both spouses consent to the arrangement.
