

Senior Cooperative Housing is a living option that offers seniors age 62 and over independence and social interaction without the routine upkeep, maintenance and expenses of home ownership. The Members of the cooperative own a share of the community with an equal voice in how the community operates. The cooperative holds the community's master mortgage and residents purchase a share of the cooperative with the right to occupy their unit within the community. In addition, there is a monthly payment to cover all maintenance costs and repairs. Although residents do not assume personal liability for the master mortgage they receive the tax benefits of home ownership, and are entitled to a deduction on their income tax return for their share of property taxes as well as interest on the mortgage. Each cooperative share appreciates in value on a limited basis of 1% per year. Members will gain on their investment, while keeping units affordable to new residents who are interested

set of bylaws and agreements that are monitored by an elected Board of Directors. Each unit or share has one vote, and only residents of the Cooperative may serve on the Board of Directors.

# The Value of Traditions

**Director of Assisted Living** For many families. traditions carry an irreplaceable value. They are often present in milestones, holidays... even everyday life. No matter the ritual, they seem to bring a sense of peace, familiarity and comfort. Whether it is wearing the same socks for a basketball game because they are lucky, or doing the nightly bedtime tuck-in and prayer with your littles, or getting to have scrumptious cupcakes from Sister-Sweets on your birthday each year, or reading 'Twas the Night before Christmas to your grandkids on Christmas Eve... traditions are born, carried on and passed on from generation to generation.

At Silveridge we acknowledge the importance of tradition.

Cronk's Café was established in Denison in 1929 and was a staple in our community for many years. It served homemade dishes to its patrons year after year, often being the go-to establishment for afterchurch family brunches or holiday meals. When Cronk's closed in 2020, its owners Eric and Terri Skoog identified the symbolism the Angus Room Christmas tree had to the community and did not want to let that disappear. They decided to donate the tree to Silveridge

so it could continue to be enjoyed by Denison residents for years to come. Our tenants, staff and visitors now enjoy it each season in our main dining room.

LaGene Webb, Silveridge tenant, began collecting Department 56 Christmas Village pieces in the early 90s when her children were looking for gift ideas to celebrate her birthday, which she happens to share with Jesus. The village was displayed every year in her home and enjoyed most by her grandchildren who would look at the lighted details in awe knowing they did not dare touch any if they wanted to live to see another Christmas. When LaGene left her home and relocated to Silveridge 3 years ago she was saddened to realize she would no longer have room to store and display her 57 piece village. Instead, she gifted it to me, her granddaughter, and it is now displayed each December in one of the Silveridge living rooms, and remains to be admired by everyone who looks at it.

LaDonna Maas who was a Silveridge tenant from 2011 until 2016 spent her entire married life collecting nativity scenes. When she came to Silveridge in 2011 she began displaying the collection of over 100 nativities for Silveridge tenants and families to enjoy over the holidays. After her passing in 2016, LaDonna's daughters wanted to keep the spirit of LaDonna and her tradition alive, and donated her largest nativity scene to Silveridge. It continues to be displayed each year. Tenants and staff who knew and loved LaDonna look at it every holiday season and remember her witty sense of humor and love for tradition.

There tends to be misconceptions that if there are changes within a family, whether that be a move or the loss of a loved one, traditions are lost. I feel these three examples prove that traditions are upheld when those who cherish them refuse to give up on keeping them alive. Traditions can be started by anyone, no matter your significance within the circle of people you want to have them with, and they can be carried on by anyone who chooses to honor their importance... even if the traditions were bott originally your own to start with. If you have not begun any traditions within your own family, I encourage you to start. If you are worried about a tradition being lost, take it upon yourself to ensure it is continued. The feelings they bring and the memories they create are something you can carry with you for years to come.

# Ways to Make Someone Smile

Although things are looking up, we wanted to compile a list of things you can do to help give a smile to the residents and tenants on the Eventide Campus, even from afar.

# **Advance Directives**

I recently attended a conference and had a very good education on the three advanced directives that Iowa recognizes. I believe these directives are something every adult should think about and make some decisions earlier rather than later about the care they may want or may not want to receive.

In Iowa a 'durable power of attorney' for healthcare means a document authorizing an attorney in fact to make health care decisions for the principal if the principal is unable, in the judgment of the attending physician to make health care decisions. The 'attorney in fact' is the person who is designated. The 'principal' is a person 18 or older who executed the power of attorney. And 'health care' refers to any care, treatment, service, or procedure to maintain diagnose, or treat an in individuals physical or mental condition.

The phrase 'durable' ensures the power of attorney is not in effect when signed, but rather becomes effective when the judgement of the person is impaired and is unable to make their own healthcare decisions. It is important for family members or the attorney in fact to understand their authority does not start until the person cannot make decisions for themselves according to physician judgement.

The medical opinion of the physician should be in writing and kept in the medical record of the resident.

When signing a healthcare POA, one of two things need to happen; 1) it is signed by at least 2 people, in the presence of each other and the principal, or 2) or signing is acknowledged by a notarial officer. Iowa law prohibits an employee of health care provider that care for the principal on date of execution from being a witness to the DPOA. Also, a health care provider or employee of health care provider, on date of execution, may not serve as attorney in fact unless the individual designated is related to the principal by blood, marriage, or adoption. The other thing to keep in mind, is that

performance of any medical procedure necessary to provide comfort care or alleviate pain. Life sustaining procedures authorizes withholding nutrition and hydration when it is provided intravenously or by feeding tube.

Witnesses to a living will cannot be 1) a health care provider attending the declarant on the date of execution or 2) employee of health care provider attending the declarant on the date of execution.

When the attending physician declares the declarant with a terminal condition, this decision must be confirmed by another physician. The determination must be recorded in the declarant's medical record.

The living will declaration may be revoked at any time and in any manner by which the declarant is able to communicate their intent to revoke, without regard to mental or physical condition. It is only effective to the attending physician to whom it is communicated by declarant. The attending physician then needs to make this a part of the person's medical record.

The living will also provides a process for decision making in absence of a resident making end of life decisions. In the absence of a living will declaration, life sustaining procedures may be withheld or withdrawn from a patient who has a terminal condition if there is consultation and written agreement for the withheld or withdrawal of life sustaining procedures between attending physician and the following individuals in the order of priority: 1) attorney in fact; 2) guardian; 3) spouse; 4) adult child; 5) parent; 6) adult sibling.

A living will standardized form that complies with Iowa's law has been prepared by the Iowa Bar Association and is available online. Also available online is a standardized form that combines both the living will and durable power of attorney for health care.

The third and final advance directive is an Out of Hospital Do Not Resuscitate (DNR) order which is set forth in Iowa code 144A.7A. These DNRs are limited to residents who are in a terminal condition. A health care provider may withhold or withdraw resuscitation outside a hospital consistent with a do not resuscitate order. A DNR order shall not apply when a patient is in need of emergency medical services due to a sudden accident or injury resulting from motor vehicle collision, fire, mass casualty, or other of sudden accident or injury which is outside the scope of the patient's terminal condition. A DNR can be revoked at any time a patient or an individual authorized to act on patient's behalf is able to communicate in any manner the intent that the order to be revoked without regard to mental or physical condition of the patient.

1. Send a note or card just saying hello and you are thinking of them. Give your loved one an update with all family member's activities, jobs, etc.

2. Encourage children to paint them a homemade picture they can hang in their room.

3. Send flowers! In Denison, A Country Rose or HyVee delivers.

4. Send their favorite snack item. HyVee delivers food, too!

5. Plan a video chat. Call Activities or Social Services to setup a time.

6. Create and send a custom calendar or photo book with family photos for your loved one's room or apartment.

7. Give them a gift card for a little pampering at the Beauty Salon on campus. Call Tina in the Business Office for details, (712) 263-3114, ext. 224.

8. Create a joyful door decoration for their room or apartment door.

9. Bring in old pictures to reminisce with your loved one.

10. At the time of this writing, visitors of all ages are welcome to visit, and the residents and tenants are able to go out of the building with family members.

resident must have 'capacity' to know what they are signing, so it is important to think of such directives earlier rather than later.

A healthcare durable power of attorney can be revoked at any time and in any manner the principal is able to communicate without regard to mental or physical condition. Revocation can be completed by notifying the attorney in fact orally or in writing. It also can be completed by notifying the health care provider who is providing care to the principal orally or in writing. This may get sticky if the resident has dementia, because once the DPOA is revoked, they may not have the capacity to sign a new DPOA, which may leave families with little choice except guardianship.

The Durable Healthcare Power of Attorney allows for a primary and a secondary attorney in fact. There is no limit for the number of people who can be assigned to attorney in fact, but there may be more problems or disputes in decision making with the more people involved.

The second advanced directive to talk about is the living will. The 'living will' is a written document authorizing a health care provider to withhold or withdraw life sustaining procedure in certain cases. A 'life sustaining procedure' could be a medical procedure, treatment or intervention which utilized mechanical or artificial means to sustain, restore, or supplant a spontaneous vital function, and which serves only to prolong the dying process. A living will is only effective when a resident is diagnosed as being terminally ill and not able to take part in the medical decision-making process.

Life sustaining procedure does not include administration of medication or

Family wishes or other individuals who are not authorized in the order to act on behalf of the resident shall not supersede a valid out of hospital do not resuscitate order.

To be compliant with nursing home standards, a nursing facility must have an acknowledgement signed by the resident or legal surrogate requesting that a DNR order be issued. This document should be maintained in the clinical record. A written order for DNR also must be obtained from attending physician and maintained in resident record.

The facility will maintain policies in which a DNR is an order that directs in the event of cardiac or respiratory arrest no CPR measure will be initiated. In the event of cardiopulmonary arrest, 911 will be called and CPR will be initiated, unless there is either evidence of irreversible death or the resident had valid DNR order issued by attending physician and is located in resident clinical record.

# **Resident Rights**

**Respect and dignity:** The resident has a right to be treated with respect and dignity, including:

The right to share a room with his or her roommate of choice when practicable, when both residents live in the same facility and both residents consent to the arrangement.

The right to receive written notice, including the reason for the change, before the resident's room or roommate in the facility is changed.

The right to refuse to transfer to another room in the facility, if the t. purpose of the transfer is:

a. to relocate a resident of a SNF from the distinct part of the institution that is a SNF to a part of the institution that is not a SNF, or

b. to relocate a resident of a NF from the distinct part of the institution that is a NF to a distinct part of the institution that is a SNF.

c. solely for the convenience of staff.

A resident's exercise of the right to refuse transfer does not affect u. the resident's eligibility or entitlement to Medicare or Medicaid benefits
