The senior living industry has certainly been a familiar headliner in the media and topic of conversations with many government officials throughout our country over the last few years. And apparently it is not about to stop. Prior to the pandemic, funding for our sector was already at levels well below costs, more so than any other healthcare provider type. Frankly, we are an industry too many want to forget about when it comes to funding or providing positive oversight. Going back to early 2020, the media was all about the pandemic with a vast number of changes hitting our industry. During this time, there was a lot of blame and frustration within our industry. This industry became a focus but for mainly for the wrong reasons. Two years later, most of the pandemic operational changes still exist and continue to add to the workload of team members in long term care. Any extra funding has been halted as the eyes of many feel and act as the pandemic is over. The Biden Administration's Nursing Home Reform Plan is slated to look at additional regulatory measures while CMS is looking to reduce reimbursement; these two things measure up to improving quality of services. We are eyeing a \$320 million proposed decrease in Medicare funding at a time when historic labor crisis and federal policies and will likely make a mark on this industry for years to come. We will continue to witness nursing facilities close across our nation. I mention this only has a reality check on how this will affect our communities at a local and national level. In addition, our industry needs voices of positive support. I was able to make a trip to Washington DC in March to speak with Federal leaders about some of the biggest issues we must come overcome together. Together is key in offering workable solutions to improve quality of care and services in our industry. If anything, it was one more voice pleading the needs of our industry.

As the Eventide Leadership embarked on one of our most challenging endeavors with the opening of Gracewell during the pandemic, our strategic plan is to be in a position to serve this community for generations to come. However, this will not come without major challenges especially if CMS and government officials decide to not fund or support this industry the way it truly needs to be. With all the challenges we face, we continue to try and focus on the positives we have on the Eventide Campus. We have a beautiful new nursing facility and have already seen improvement with residents' activities of daily living. Many residents are eating more, exercising more, and socializing more. Our facility is one of the few 5 STAR ratings as set by CMS. Silveridge Assisted Living continues to have over a decade of perfect state surveys, high tenant satisfaction ratings, and outstanding support staff. Heritage Heights and Realife have seen success with steady occupancy levels and high tenant satisfaction surveys. The Eventide Foundation has seen an increase in the number of donors as awareness about this purpose continues to grow. We have longevity among our team who continue to show dedication toward our mission of serving those of age. The number of amazing volunteers on our campus continues to grow which leaves a much-needed positive impact. For all this and the challenges that lay ahead, we truly are blessed.

Clearing the Assisted Living Air

Recently I was visiting with an individual in the community and we were discussing assisted living. This individual mentioned, "I don't think Mom would want to live in assisted living because she does not like people telling her what to do." I could not help but giggle to myself, simply because I often hear these kinds of misconceptions. So, I decided to choose a few of the most common pieces of misinformation out there and take this opportunity to 'clear the air' on assisted living.

"They tell tenants what to do."

In the 11 years I have been at Silveridge, the one thing I am most passionate about is advocating for tenant rights. Chapter 67 in the Iowa Administrative Code describes some of the key rights tenants have in assisted living:

- 1. To be treated with consideration, respect, and full recognition of personal dignity and autonomy
- 2. To receive care, treatment and services which are adequate and appropriate
- 3. To receive respect and privacy in the tenant's medical care program. Personal and medical records shall be confidential, and the written consent of the tenant shall be obtained for the records release to any individual, including family members, except as needed in case of the tenant's transfer to a health care facility or as required by law or third-part payment contract
- 4. To be free from mental and physical abuse
- 5. To receive from the manager and staff of the program a reasonable response to all requests.
- 6. To associate and communicate privately and without restriction with persons and groups of tenant's choice, including the tenant advocate, on the tenant's initiative or on the initiative of the person or groups at any reasonable hour.
- 7. To manage the tenant's own financial affairs unless a tenant's legal representative has been appointed for the purpose of managing the tenant's financial affairs.
- 8. To present grievances and recommended changes in the program policies and services, personally or through other persons or in combination with others, to the program's staff or

person in charge without fear of reprisal, restraint, interference, coercion, or discrimination.

9. To be free from restraints

It is not always easy to interpret formal regulations or verbiage, so let me summarize: You have the right to govern your day, your choices, your services, your life just as you did before assisted living. If you want to sleep in until 10:00am, you can. If you want to maintain your independence with all of the tasks in your day, you can. If you want to meet your friends for Friday morning coffee, you can. If you want to go the Bahamas on a winter cruise, you can (as long you bring me too). Choosing to move to assisted living may sound like you would be giving up your independence or freedoms, but it is actually designed to enhance and support that very thing.

"I won't have any privacy."

With two different spacious apartment floorplans to choose from, tenants are able to transform their new home into the perfect space. This space is their own private haven, a place for them to continue to do things they enjoy such as making their morning pot of coffee, sewing, visiting with family and friends, watching the daily dose of The Price is Right, or whatever you used to do in your house. The only difference is, should the tenant get lonely or need assistance there is someone in the building 24 hours a day that is just a pendant push away.

"Assisted living doesn't really have many

While assisted living is not staffed like a skilled nursing facility such as Gracewell (we are not intended to be) we always maintain adequate staff to ensure we meet tenant needs. One thing I found interesting in assisted living is there really only has to be one registered nurse in the program by regulation. ONE... in the entire program! The remaining staff can be medication managers or uncertified/unlicensed universal workers.

Silveridge proudly holds a higher standard to this rule. We currently have 4 registered nurses and 3 licensed practical nurses on our team, in addition to our medication managers and tenant companions. We strive to have a nurse providing care on the floor for the 6:00am-2:00pm and the 2:00pm-10:00pm shifts and utilize a medication manager for the overnight shift (in addition to an RN who is on call 24/7). So, in short, Silveridge is 'nurse heavy'. This is certainly something we take pride in and feel is something that gives tenants and families peace of mind.

"I don't think Mom or Dad NEED assisted living yet."

If I have learned anything in my years in assisted living, it is that tenants more often than not wait too long to come. Assisted living is designed to support independence while providing amenities that enhance quality of life. ANYONE can benefit from that. We have tenants who move to Silveridge simply because they do not want to have to cook, buy groceries or do dishes anymore. Some move in just so they do not have to be alone. They virtually receive no health care services and simply enjoy the activities, meals, weekly housekeeping and seeing friends. It is never too soon to enjoy the amenities and benefits assisted living offers.

On the other hand, because assisted living regulations set certain criteria for admission and retention, some who want to come to us 'when they are ready' are already close to or are exceeding level of care and no longer a candidate. This is a heartbreaking situation for me and for the tenant and their family who hoped to enjoy assisted living, and unfortunately, I see it often. My only advice to you on this would be: if you have any interest in assisted living whatsoever; make the call, take the tour, ask the questions, talk to other established tenants, try a meal in our dining room, and get a feel for the atmosphere. Try it out. I promise (and our current tenants would agree) you will not regret it!

Although there are other misconceptions associated with assisted living, I am likely taking up enough space in the Events for now, so I encourage you to reach out to me and ask anytime you may have a question. I do hope I have 'cleared the air' on some common assisted living misconceptions! After my 11 years here, I can wholeheartedly say I LOVE assisted living and what it offers for seniors.

Welcome To Gracewell Family & Friends!

Visitors are welcomed! Here are a few things to keep in mind as you visit residents or employees at Gracewell.

The nursing facility address will remain the same as prior, 114 South 20th Street in Denison. The Business Offices, formerly located at the Heritage Heights apartments, have moved and can now be found within Gracewell. Our Main Entrance is now facing East and you can find the visitor parking from 20th Street. When you enter the vestibule, you will now see a tablet that will complete the COVID-19 health screen before you visit. This screening machine is called an Accu-Shield. Several nursing facilities have changed from paper screens to the machine as it is quicker and more accurate for health screens. Here are some quick directions for using the Accu-Shield.

To start, tap the screen

Select Sign In

Select Family or Guest

Enter your cell phone number. Enter your first and last name.

You will be shown a facility policy for visiting residents, select 'I Accept' after reading if you are in agreement.

Answer the health screening questions. Confirm your answers are correct.

To take your temperature, line your eyes up on the screen in the two circles and hold your head still. Your temperature will automatically be taken. It is best to not wear both glasses and face mask during the temperature reading.

The machine will ask if you are vaccinated the first time and then not again when you enter your phone number.

The machine will ask which resident at Gracewell you will be visiting; you will enter their last name, and their name will pull up from drop down box. You can then select the resident from a drop-down box. The Accu-Shield will remember who you are selecting a visit with, and will select this name for you next time.

The machine will print you a badge to prove you passed the health screening. Please wear this badge when in the facility.

After you have completed your screening, you will need to ring the doorbell. This is the silver button on the wall with an intercom. Our staff will be able to communicate with you, and will have to buzz you into the building if you have passed your screening.

When exiting, you do not have to "Sign Out" at this time.

If at any point you are struggling with the screen in process, please push the doorbell to talk to staff or call Gracewell at 263-3114.

Resident Rights

Self-Determination: The resident has the right to and the facility must promote and facilitate resident self-determination through support of resident choice, including but not limited to:

a. The resident has a right to choose activities, schedules (including sleeping and waking times), health care and providers of health care services consistent with his or her interests, assessments, and plan of care and other applicable provisions of this part.

b. The resident has the right to make choices about aspects of his or her life in the facility that are significant to the resident.

c. The resident has the right to interact with members of the community and participate in community activities both inside and outside the facility.
