Gracewell and Blue Stone Therapy Partner to Bring the Head, Hands, Heart Approach to Memory Lane

Almost 6 million people in the United States are living with a diagnosis of dementia. While becoming 'less sharp' is generally accepted as a normal part of aging, true dementia is much more severe and progressive in nature. It is demonstrated by consistent and pervasive forgetfulness, inability to hold conversations, and general disorientation that is persistent. The physical and mental impact of dementia often leads families to seek out the care of skilled nursing facilities that are specially equipped to help their loved ones.

Gracewell is committed to serving residents with dementia and their families by helping them preserve their quality of life. Gracewell has partnered with Blue Stone Therapy to bring specialized clinical programming for these very special people through Blue Stone Therapy's Head, Hands, Heart approach to dementia care.

The Head, Hands, Heart approach to dementia care starts with occupational and speech therapists completing thorough assessments in order to accurately determine a resident's current stage of dementia. In addition, therapists interview the residents, caregivers, family, and friends to determine the residents' previous roles, routines, and the meaningful activities a resident took part in prior to their onset of dementia. Armed with this knowledge, therapists develop specific strategies that capitalize on what a resident can do, what

they can remember, and what they like to do and are used to doing. Therapists are then able to train the nursing, activities, and dietary staff on how to use these effective tailored approaches to improve the quality of life of these residents.

In July, Gracewell staff will also receive training by Blue Stone Therapy clinical leaders on how to use the Head, Hands, Heart approach to dementia care in daily interactions with all residents. Through this training, staff will understand the different stages of dementia, positive ways to speak to and assist residents with dementia in various stages, and how to create a game plan for when residents may be in distress and need help with challenging behaviors.

Angie Landauer, OTR/L is the Director of Clinical Services for Blue Stone Therapy and has worked to develop and present the Head, Hands, Heart approach to dementia care for therapists and caregiver staff. "Dementia is a diagnosis that presents unique challenges. Through Blue Stone Therapy's Head, Hands, Heart approach to dementia care, frontline staff gain the tools they need to successfully help our residents with dementia get the most out of life."

Scammers Targeting the Elderly Population

We hear it more and more often these days about scammers targeting the elderly population. Our elderly are very vulnerable, especially in this world of technology that can be hard for them to navigate. According to Office for Victims of Crime, "Fraud and romance scams aimed at older adults resulted in losses of more than \$184 million in 2018."

In recent years a fraud hotline has been set up by the US Senate Special Committee on Aging to help protect seniors from internet and telephone scams. The number for this hotline is 833-FRAUD-11 or 833-372-8311. This is a free resource. It is important to report any scams you have been victim to in order to prevent others from being scammed by those very same people. Below are some quick tips to know when something could be a scam.

1. If the person threatens you to make a decision fast, it could be a scam.
2. If they try to get your personal information, such as Social Security Number or bank information, it could be a scam.
3. If they are offering free travel vouchers, it could be a scam.
4. Scammers look at obituaries to find people to target. They prey on those who are not in a clear mindset. Scammers are known to use the love you have for your

family against you. Never wire money to them to help fix a problem (needing bail money, paying a bill) for your loved one.

5. Government entities will NEVER ask for immediate payment and will NEVER ask for payment without sending a paper bill first.
6. If you are questioning if something may be a scam, ask for their name and phone number and state you will return their call later.
7. Most scams lead you to believe one of two things- something amazing will happen to you (winning money) or something absolutely terrible will happen to you (your house will be foreclosed on).
8. When trying to meet a significant other online, always remember someone may not be who they seem. You should never send/wire a love interest any form of money.
9. Use a good anti-virus software on your computer. Consult local IT companies to assist in finding a reputable software.
10. Remember, you should never have to pay a fee in order to win a prize.
11. Elderly are often victims of fraud because they're isolated and don't have anyone checking their finances until it is too late. That isolation also causes them to be easy targets as scammer's use that need for social interactions as their way in.

NEW RECIPE ALERT

Strawberry Bread Pudding



- | | |

| 4 cups bread slices, cubed | Sauce |
| 3/4 cups Fresh Strawberries sliced/chopped | 1 cup Unsalted Butter |
| 3 Eggs | 1 cup Heavy Cream |
| 1 cup Milk | 1 cup Sugar |
| 1/2 cup Vanilla yogurt | |
| 1/2 cup Sugar + 2 tbsps | |
| 2 tsp Cinnamon divided | |
| 1/2 tsp Nutmeg | |

1. Preheat oven to 350°. Spray an 8 or 9 inch baking dish with cooking spray. Toss bread with the chopped strawberries, and place into the prepared pan.
2. In a large bowl, whisk together the yogurt, milk, eggs, 1 tsp cinnamon, nutmeg, and 1/2 cup sugar.
3. Pour over the bread mixture and lightly press down with a spatula until the bread has absorbed the milk mixture.
4. In a small bowl, stir together 2 tbsps sugar and 1 tsp cinnamon. Sprinkle on top the bread pudding. Bake 30-40 minutes until puffed and golden brown.
5. While the bread pudding is baking, make the cream sauce. In a saucepan over medium-low heat, stir together the butter, heavy cream, and sugar; bring to a boil.
6. Reduce heat to low, simmer until the sauce thickens, for about 5 minutes. Pour over bread pudding to serve. Top with strawberry or vanilla ice cream.

CDC Revises COVID-19 Vaccine Up to Date Definition

On May 24, the CDC released revised guidance documents changing the definition of "up to date" with COVID-19 vaccines, to include the recommendations for a second booster dose.

What this means for our residents?

All residents who do not meet the new definition of up to date must:

- be quarantined upon admission for at least 7 days and then must test negative
- be quarantined upon readmission from hospital or a 24+ hour out of building stay for at least 7 days and then must test negative
- remain in their rooms in the event of broad-based testing approaches in a COVID-19 outbreak.

Key CDC Changes:

Recommended 1 Booster

- Everyone ages 5 years and older should get 1 booster after completing their COVID-19 vaccine primary series.

Recommended 2 Boosters

- Adults ages 50 years and older
- People ages 12 years and older who are moderately or severely immunocompromised

All residents (except someone under age 50) are now recommended to have the second booster once eligible.

New CDC Recommendations for COVID-19 Vaccines

(published May 24, 2022)

Individuals Not Considered Moderately or Severely Immunocompromised Ages 50+:

- A primary series includes one of the following:
 - o Moderna. A two-dose series with the second dose being administered between 4-8* weeks following receipt of the first dose.
 - o Pfizer. A two-dose series with the second dose being administered between 3-8* weeks following receipt of the first dose.
 - o Johnson & Johnson's Janssen*** which is a one-dose series.
- A first booster dose should be administered:
 - o Pfizer & Moderna. At least 5 months after the completion of the primary series for all individuals ages 5 and older.
 - o Johnson & Johnson's Janssen. At least 2 months after the primary dose of a J&J vaccine.
- A second booster dose should be administered:
 - o Pfizer & Moderna. At least 4 months after the first booster dose.

Moderately or Severely Immunocompromised Individuals Ages 18+:

- A primary series includes one of the following:
 - o Moderna. A three-dose series with the second dose being administered 4** weeks following receipt of the first dose and a third dose being administered 4-weeks following receipt of the second dose.
 - o Pfizer. A three-dose series with the second dose being administered 3** weeks following receipt of the first

dose and a third dose being administered 4-weeks following receipt of the second dose.

- o Johnson & Johnson's Janssen***. A two-dose series with the second dose being administered at least 4-weeks (28 days) after the first dose.
- A first booster dose should be administered:
 - o Pfizer & Moderna. At least 3 months after the completion of the primary series.
 - o Johnson & Johnson's Janssen***. At least 2 months after the primary series of a J&J vaccine.
- A second booster dose should be administered:
 - o Pfizer & Moderna. At least 4 months after the fourth dose (or first booster dose). Note individuals who received the J&J vaccine as a primary and/or booster vaccine should receive an mRNA vaccine for the second booster dose.
 - o J&J cannot be used as a second booster dose.

How to define up to date with COVID-19 vaccinations: An individual is considered up to date with COVID-19 vaccinations, including booster doses, when they have received all vaccine doses according to the CDC's recommendations. The CDC recently updated recommendations for receipt of COVID-19 vaccination doses.

- A person who has received the primary series, but is not yet eligible for a booster dose, is considered up to date.
- A person who is eligible for a booster dose, but has not yet received it, does not meet the definition of up to date.

Annual Meeting Save the Date

Resident Rights

Self-Determination (cont): The resident has the right to and the facility must promote and facilitate resident self-determination through support of resident choice, including but not limited to:

- d. The resident has the right to receive visitors of his or her choosing at the time of his or her choosing, subject to the resident's right to deny visitation when applicable, and in a manner, that does not impose on the rights of another resident.
 1. The facility must provide immediate access to any resident by –
 1. Any representative of the Secretary,
 2. Any representative of the State,
 3. Any representative of the Office of the State long term care ombudsman,
 4. The resident's individual physician,
 5. Any representative of the protection and advocacy systems, as designated by the State, and as established under the Developmental Disabilities Assistance and Bill of Rights Act of 2000
 6. Any representative of the agency responsible for the protection and advocacy system for individuals with a mental disorder,
 7. The resident representative.
