From the CEO

The Eventide Campus recently held our Annual Meeting which is a great time to reflect on our previous fiscal year.

Yearly Highlights:

Opening of Gracewell, our new nursing facility that replaces the older structure. This project was made possible with generous donors, business equity, and securing USDA funding at 2.5% interest for 40 years. We were able to refinance the Silveridge building loan with these funds as well. We had over 10 different types of audits on campus and each one ending with good results; the time and dedication our team conducts to prepare for such audits is shown in the outcomes. Gracewell remains a 5 STAR as set by CMS (Centers of Medicare and Medicaid); the highest rating available. With fewer and fewer facilities reaching this status throughout the United States, it is certainly something we pride ourselves on. Silveridge remains deficiency free since opening day and tenant satisfaction surveys remain very high. The team at Silveridge continues to work hard to meet the needs of tenants and their families. Implementation started on new HRIS (Human Resource Information Systems) which has been an undertaking in itself. However, we feel this will better serve our team members with resources they need, when they need it. Gracewell decertified down to 84 beds to allow for better staff to resident ratios. As with each segment in our business, we are here for people, not for profit. We continue to work hard to enhance employee benefits and this year employee premium costs remain unchanged as Eventide carried the increase on

plans. Eventide adjusted wage scales for a number of positions with more on the horizon. We increased the employer match on the 401 (k) from 3% to 4% which is above the average match. Our year was also spent dealing with COVID-19 regulations such has vaccine mandate, numerous required reporting, screening visitors/staff, frequent testing, etc. It has been a challenging ride at times but the Eventide Campus Team remain dedicated to fulfilling this role in caring for the aging population. Census in each building certainly is a huge factor financially. The number of admissions in each building increased this year over the past; likely the pandemic played a part in this as the world was 'somewhat' back to normal. We are slowly rebounding back to pre-pandemic levels.

Looking ahead we certainly need to advocate for our industry in areas of appropriate reimbursement by Medicaid and Medicare, COVID-19 Relief, and easing some regulatory requirements. A strong focus within our campus this year will be employee retention. We have an outstanding team in each building which we must strive hard to retain. A large aspect of this will be from feedback from team members and finding a balance to accommodate the needs of everyone involved. Right alongside that focus is resident & tenant satisfaction. It is all part of our mission. Our Mission Statement we want to focus our daily decisions on is: We strive to be the Health Care Provider of Choice & the Employer of Choice by understanding & exceeding the expectations of our Residents, Families & Employees.

Gracewell Residents Leaving Facility with Family or Friends

For resident safety, any time a resident leaves the building, the charge nurse must be notified. If you are planning to take a resident out of the building, you and/or the resident must first inform the nurse on the household. At that time, you will sign the resident out with the nurse and any other instructions that might be needed are given at this time. When returning with the resident, you must check back in with the nurse on duty to let them know that the resident has returned. We can't stress enough that the process of resident check in and out is a must. Federal/ State regulations defines an elopement as the act of a resident leaving the facility without staff knowledge. Because of this, we feel it is important to educate residents, families, and community members on the process at Gracewell.

Medicare Annual Open Enrollment

Medicare's annual election period runs from October 15 through December 7 each year. During this annual window, Medicare plan enrollees can reevaluate their Medicare coverage and make changes or purchase new policies if they wish to do so. During this open enrollment period you can choose to:

• Do nothing and your current Medicare coverage will automatically renew in 2023

• Enroll in, leave, or change your Medicare Part D drug plan

• Switch from Traditional Medicare to a Medicare Advantage plan

• Switch from a Medicare Advantage plan back to **Traditional Medicare**

• Change from one Medicare Advantage Plan to another

Please note that seniors who live in a Nursing Facility can make these changes at anytime if they are unhappy with their current selection.

Today seniors have more options than ever before. There are several things to consider when choosing the right Medicare plan for you and your pocketbook. Aside from the premiums, there are deductibles, coinsurance, and copayments to consider in calculating your total Medicare spending. Other issues like prescription drug coverage, and provider networks may also factor into your choice. Here's a quick overview of your Medicare options.

and peace of mind that comes from knowing exactly how much you will spend on a hospital stay or chronic illness.

One major thing to take into consideration is that with Original Medicare you and your physician have the freedom to choose your plan of care. There is no need for prior authorization for many medical services and your physician will be able to decide when to start and stop treatment. Medicare Advantage Plans require prior authorization for many medical services and the decision for coverage for those services is made by a professional hired by the insurance company and not your primary care physician.

Medicare Advantage

Medicare Advantage is a popular alternative to Original Medicare. Also known as Medicare Part C, Medicare Advantage is technically still a part of Medicare, but it is not sold or managed by the federal government. The government sets rules and guidelines, but private insurance companies sell and administer these plans. Advantage Plans offer the same benefits as Original Medicare but many go beyond and offer other coverage like routine vision and dental care to their members. Medicare Advantage plans will have different networks and copays. It is very easy to obtain a Medicare Advantage plan as long as you live in the plan's service area and are enrolled in Part A and Part B.

Resources to Support the Elderly in Crawford County

Crawford County has several resources out there to help your loved one remain in their homes, but also provide caregivers with a break. I want to highlight just a few of our many resources, but please feel free to reach out to me, Morgan Saunders, Social Worker at Gracewell, if you are looking for other services. I can be reached at 712-263-3114, ext. 238.

• Eventide Campus Monthly Alzheimer's Support Group meets on the second Tuesday of the month at 1:30pm at Gracewell. This is open to anyone helping a loved one battling Alzheimer's, Dementia, and aging. Call Gracewell with questions at 712-263-3114.

• CoCares is a non-medical helping service for the elderly and for caregiver relief. It can be visiting, hobby sharing, or practical helping like meal preparation, errands, or cleaning. It is fee based, but the individual fees are offset with charitable donations received for the program! Crossroads can be reached at 712-393-4673 or info@crossroadsofcrawfordcounty.org. They also provide another service for unplanned pregnancy and parenting. • Angels Care Home Health is a home health care company serving Crawford County and 5 surrounding counties. They are 100% Medicare-covered but also work with the VA and take some insurances. Angels have several specialty programs including Alzheimer's and Dementia, a pre-palliative program, and Behavioral Health to name just a few. You can reach Angels Care Home Health at 712-263-2266 or Karen at 712-269-4317. • Veteran's Assistance- A Veteran, or a surviving spouse of a Veteran, who served a minimum of 90 days of honorable service with one day in a wartime period may be eligible for VA pension benefits. There are income and asset limitations. Louise Galbraith, Crawford County Veterans Affairs Service Officer, can explain the process in more detail, and will complete any and all paperwork. This benefit is for nursing home and assisted living residents. Louise can be reached at (712) 263-2720 or stop and see her on the first floor of the Crawford County Courthouse. • A Caregiver Support Group was formed by health professionals in the last several months. The group meets the second Thursday of each month at the Crawford County Memorial Hospital at 3:00pm. A main goal of the group is help with the isolation and stress that caregiving can bring. Each month there is a short speaker on a topic that the group is interested in, and plenty of time for sharing. • Crawford County Community Health provide in-home medical services to the elderly population to help them remain home-bound if possible. Hospice services are available to those with a terminal diagnosis and can be provided in the home or in a facility. Both services can be reached at 712-263-3303, ext. 9. Hospice and Home Health are both funded by Medicare and usually have minimal to no copay for the services.

Original Medicare

Under Original Medicare your benefits are paid directly from the federal government. Benefits are separated into two parts, Part A and Part B. Part A covers your inpatient care and Part B covers your outpatient care. Part B also covers certain Medical equipment such as wheelchairs and home oxygen supplies. You do not have to pay a premium for Part A coverage if you have a qualifying work history. The Part B premiums are set each year by the federal government.

With Original Medicare the benefits are exactly the same for every person who enrolls. There are no pre-existing condition limitations or waiting periods. There are no networks, you can use any healthcare provider in the country who accepts Medicare. You will pay the same amount for covered services from any participating provider that you choose.

Original Medicare does not offer prescription drug coverage. Medicare enrollees can purchase Part D Prescription Drug Plans that are offered by private insurance companies. Your insurance agent or your pharmacy are good resources in helping choose the right plan for your prescription drug needs.

One thing to keep in mind if you choose Original Medicare benefits is that there is no out-of-pocket maximum each year. For this reason, most people who choose Original Medicare will also buy a Medigap plan. Medigap plans pick up where Medicare leaves off. There are many options for Medigap plans. Some plans even cover all deductibles and coinsurance, leaving you with no out-of-pocket for your medical services.

Most people who choose Original Medicare plus a Medigap plan value freedom of access to Medicare's entire network of providers. There is no need to choose a primary care provider for this plan and you do not need a referral to see a specialist.

Another advantage to choosing Original Medicare and a Medigap Plan is because your out-of-pocket costs are predictable. You can enjoy the convenience

The two most popular Medicare Advantage Plans are HMO's and PPO's. Health Maintenance Organizations (HMOs) have closed provider networks and you generally must get all but emergency care within your plan's network. Your plan may require you to get a referral for specialist care and prior authorization for certain tests and procedures. Preferred Provider Organizations (PPOs) plans also have provider networks, but you can still use any provider that accepts Medicare. You'll pay a lot less out-of-pocket if you stay in your network, however.

Each Medicare Advantage plan can choose what to charge for premiums, deductibles, and copayment amounts. In some areas there are "zero premium" plans available, that don't add additional premiums above what you are already paying for Part B. Deductibles may apply to inpatient services, outpatient services or Part D. Generally, you'll have lower premiums if your plan has a higher deductible. Medicare Advantage enrollees usually pay a copayment when they receive services and there is often a tiered copayment system for prescription drugs.

There is one very important difference between Original Medicare and Medicare Advantage. Medicare Advantage plans have a maximum out-ofpocket limit for enrollees. Once you hit the maximum, you pay nothing for covered healthcare for the rest of that calendar year. Medicare Advantage plans often appeal to people who have low medical usage. If you rarely go to the doctor, then the cheaper premiums on Medicare Advantage will be attractive to you. You can pay for your services as you us

Both types of coverage offer reputable Medicare insurance. You just need to consider the total costs (premium, deductible, coinsurance, copayment) and your healthcare needs to get a clear picture of which plan is best for you. Joyful Moments at Silveridge Assisted Living



The Facts of Life... at Heritage Heights

I get asked questions all of the time about what Heritage Heights is. I find that many people do not have a clear understanding of what we really are, and who qualifies to live here. I thought I would highlight a few of the key aspects about our wonderful building so you could see for yourself if you meet the requirements.

We would love to have you join us!

• Heritage Heights consists of 35 affordable apartments that are subsidized by HUD (Housing and Urban Development). Apartments consists of studios & 1 bedroom units.

• No one pays the same amount of rent, as it based on 30% of your adjusted gross income. To get to a person's adjusted gross income, we are able to deduct certain expenses such as qualifying medical insurance premiums and healthcare related costs.

• To qualify to live here, a single person's income must be below \$27,800/year or below \$31,750/year for a couple. You may also have assets.

• Many who are receiving social security as their only

form of income could qualify.

• The head of household must be 62 years of age or older.

• Handicapped individuals also qualify if they are over the age of 18 and meet the requirements for this special designation.

• Lunch & supper meals can be provided by Gracewell at a low cost.

• Transportation to the grocery store is provided once every two weeks.

• Maintenance free living. Maintenance on call 24 hours.

• All utilities are included, with tenant being responsible for telephone, cable and internet.

- Laundry facilities on site
- Fitness Room
- Party room for family gatherings
- Quiet & Safe Environment

Resident Rights

Self-Determination (cont): The resident has the right to and the facility must promote and facilitate resident self-determination through support of resident choice, including but not limited to:

d. The resident has the right to receive visitors of his or her choosing at the time of his or her choosing, subject to the resident's right to deny visitation when applicable, and in a manner, that does not impose on the rights of another resident.

ii. The facility must provide immediate access to a resident by immediate family and other relatives of the resident, subject to the resident's right to deny or withdraw consent at any time;

iii. The facility must provide immediate access to a resident by others who are visiting with the consent of the resident, subject to reasonable clinical and safety restrictions and the resident's right to deny or withdraw consent at any time;
